Used Trulicity pens: To get a free sharps container for used Trulicity pens, click on the link below and complete the fields in the purple box at the bottom of the page.

Mail-back programs: Used sharps are placed in special containers, which are mailed (in accordance with U.S. Postal Service requirements), to a collection site for proper disposal. Mail-back programs are available for individual use by sharps users, and can also serve as a disposal method for community collection sites. These programs work especially well for rural communities, communities that don't already have a medical waste pickup service (e.g., school systems, retail outlets, sporting arenas, casinos), and individuals who wish to protect their privacy. Please look online for U.S. Postal approved mail back programs.
